## INTRODUCTION

A harmonised clinical consent will:

Ensure clear understanding for patients

- Promote voluntary agreement through open communication
- Establish a systematic documentation process
- Enhance transparency, accountability and peer consensus

#### Why do I need this [the procedure / treatment / surgery]?

#### What does it involve?

Describe the nature of the proposed [procedure / treatment / surgery], which may include some or all of the following:

- How the treatment is performed?

#### What precautions must I take for the [the procedure / treatment / surgery]?

- You are taking drugs (e.g. Aspirin, Clopidogrel, Warfarin, and Rivaroxaban) or supplements (e.g. Cordyceps, Ginkgo Biloba, and Lingzhi) that thin your blood, as these substances may affect blood clotting and increase the risk of bleeding. If you are taking any of these, your doctor will advise you accordingly.

#### What are the risks and complications of [the procedure / treatment / surgery]?

The following are potential complications of the procedure (non-exhaustive):

- Any temporary complications along with [procedure / treatment / surgery] for these temporary conditions
- 2. Any significant permanent results and long term physical, emotional, mental, social, sexual complications
- Other risks that are reasonably foreseeable, such as injury to surrounding structures and their sequelae

#### What are my options?

- Include the following:
- Any other existing alternatives to the [procedure / treatment / surgery], including the benefits and risks of the alternatives
- Explanation of the reasons the [procedure / treatment / surgery] prescribed is preferred over the other alternatives
- Likely consequences of not choosing the proposed [procedure / treatment / surgery], or of not having any [procedure / treatment / surgery] at all
- You may also choose not to undergo the procedure with the risk of delayed diagnosis and treatment, and further disease progression. You may discuss these options in more detail with your doctor.


